We will be hosting an Open Forum and Workshop on December 4 from 10.00 AM to 2.00 PM to discuss some of the grand challenges and big ideas with the input received from the NJIT community so far. ## In the News...

(National and Federal News Related to Research Funding and Grant Opportunities)

**Program Integrity Investigations:** National Science Foundation Office of Inspector General released its semi-annual report NSF-OIG-SAR-61 to the congress on investigations conducted for program integrity on funded research grants and contracts. The NSF Office of Inspector General (OIG) promotes effectiveness, efficiency, and economy in administering the Foundation's programs; detects and prevents fraud, waste, and abuse within NSF or by individuals who receive NSF funding; and identifies and helps to resolve cases of research misconduct. OIG was established in 1989, in compliance with the Inspector General Act of 1978, as amended. Because the Inspector General reports directly to the NSB and Congress, the Office is organizationally independent from the Foundation. *FORMER PROFESSOR INDICTED FOR EMBEZZLEMENT* We received information that a university professor was inappropriately directing NSF award funds to his wife's company. Our investigation revealed that NSF funds were paid to a media company, which was directed to develop websites for the university's NSF-funded center and for the professor's wife's company. The professor resigned his university position and was subsequently charged by the local prosecutor's office with one felony count of embezzlement. Our investigation is ongoing.

*NSF SUSPENDED AWARDS; PI LEFT COUNTRY AND RESIGNED FROM UNIVERSITY* We learned that a PI at a university was involved in a foreign government talent recruitment program

*and may have additional overseas employment. We subpoenaed the PI for information related to positions of employment or consulting outside of the university. The PI only provided an application related to a foreign government talent recruitment program, despite open source information suggesting the PI was already a program member and was employed overseas. Based on our recommendation, NSF suspended the PI's awards pending the outcome of our investigation. Subsequent to the award suspension, the PI left the U.S. and resigned from the university. Our investigation is ongoing.*

*NSF TERMINATED AWARDS TO PI WHO FAILED TO DISCLOSE FOREIGN AFFILIATIONS We interviewed a PI as a part of an investigation and subsequently determined that the PI had been untruthful in the interview regarding his affiliation with a foreign government talent recruitment program and institutions outside of his U.S. university. The PI also failed to disclose his position at a foreign institution in his NSF proposals. During the course of our investigation, the PI resigned from his position at his U.S. university for a position overseas. Based on our recommendation, NSF terminated the PI's active awards, resulting in more than \$500,000 in funds put to better use.1 NSF SUSPENDED AWARDS PENDING FURTHER INVESTIGATION An NSF PI was indicted on charges of wire fraud and program fraud for an alleged scheme to defraud NSF, another Federal agency, and a U.S. research university. The PI received Federal grant money, including salary, while he was employed by an overseas research university, an alleged conflict of interest that was not disclosed to the U.S. research university. Based on our recommendation, NSF suspended three awards involving the PI, pending completion of our investigation*

### **Cleaning the Air: Federal RD&D Initiative and Management Plan for Carbon Dioxide Removal**

**Technologies:** A report posted on the website <https://www.dropbox.com/s/2y36ngfrcbpv37f/EFI%20Clearing%20the%20Air%20Full%20Report.pdf?dl=0> summarizes operations of *Cleaning the Air* initiative. Net-zero carbon dioxide(CO<sub>2</sub>)emissions is not credibly achievable by midcentury without major contributions from negative-carbon technologies. Such technologies will also make possible, in the long term, a reversal of ever increasing greenhouse gas(GHG)concentrations in the atmosphere, thereby reducing the impact of past actions. Concerns about the inadequacy of collective emissions mitigation efforts, a growing body of scientific evidence, and current emissions trajectories are reflected in the actions of many foreign governments, including many U.S. states and cities, in their movement towards “net-zero” emissions targets to balance GHG emissions with an equivalent amount of carbon removal and sequestration. The growing number of national, state, and subnational entities that have committed to net-zero emissions puts additional pressure on innovators to develop a range of technologies that go beyond the scope of conventional mitigation options. This report provides a set of recommendations and detailed implementation plans for a comprehensive, 10-year, \$10.7 billion research, development, and demonstration(RD&D) initiative in the United States to bring new pathways for technological carbon dioxide removal (CDR) to commercial readiness.

**Science Committee Adds Rural STEM Education to Broadening Participation Push:** The House Science Committee approved legislation this month dedicated to supporting rural students and educators, the latest in a series of bills it has advanced that aim to broaden participation of underrepresented groups in STEM fields. The House Science, Space, and Technology Committee has passed by voice vote **a bill directing** the National Science Foundation to investigate a variety of ways to improve STEM education for some 60 million rural Americans. Finding this group to be significantly underrepresented in STEM fields, the measure provides, among other things, grants for research on effective STEM teaching practices in rural settings; professional development for rural Pre-K-12 teachers; and development of trans-disciplinary teaching practices. Sponsored by ranking Republican Frank Lucas of Oklahoma and backed by chair Eddie Bernice Johnson (D-Texas), the legislation also sets up R&D and a \$5 million prize

competition to stimulate broadband access for the many rural residents who don't have it. A complete report is posted on the website <https://www.aip.org/fyi/2019/science-committee-adds-rural-stem-education-broadening-participation-push>.

**National Strategic Computing Initiative Update: Pioneering the Future of Computing:** The national computing landscape is undergoing rapid evolution along multiple dimensions due to the introduction of new and potentially disruptive technologies and the demands of new classes of data intensive applications. Computer architectures and systems are more heterogeneous and complex, and the challenges associated with the complexity and sustainability of software are significant. Application developers are being called to meet demands for improved usability and productivity. Therefore, to address this new environment, it is essential to update the 2016 U.S. Strategic Computing Plan<sup>1</sup> in a holistic and synergistic fashion that involves government, academia, and industry. The Office of Science and Technology Policy and the National Science and Technology Council Subcommittee on Networking and Information Technology Research and Development created a Fast Track Action Committee on Strategic Computing in June 2019 to address this imperative.

The refocused objectives identified are:

1. Pioneer new frontiers of digital and non-digital computation to address the scientific and technological challenges and opportunities of the 21st century.
2. Develop, broaden, and advance the Nation's computational infrastructure and ecosystem.
3. Forge and expand partnerships for the future of computing to ensure American leadership in science, technology, and innovation.

What follows includes key goals for a strategic approach to the future of computing, and a set of recommendations to achieve those goals, which will expand our scientific knowledge, enable economic growth, and improve our national security. These recommendations and goals were determined via engagement with government, academia, and industry through various means, including a Request for Information (RFI)<sup>2</sup> and a Future Computing Community of Interest Meeting.

**Hearing Update: Senate Subcommittee Holds Hearing on Securing U.S. Research from China's Talent Recruitment Plans:** On November 19, the U.S. Senate Homeland Security and Governmental Affairs Committee's (HSGAC) Permanent Subcommittee on Investigations (PSI) held a hearing entitled, "Securing the U.S. Research Enterprise from China's Talent Recruitment Plans." The hearing included witnesses from the Federal Bureau of Investigation (FBI), National Science Foundation (NSF), National Institutes of Health (NIH), Department of Energy's (DOE) Office of Science, and the U.S. Department of State's Bureau of Consular Affairs (State). In conjunction with the hearing, a bipartisan PSI staff report, Threats to the U.S. Research Enterprise: China's Talent Recruitment Plans, was released. The committee also released two appendices with examples of talent recruitment contracts and case studies of recruitments.

The research agency witnesses all acknowledged the essential role that international collaboration and cooperation play in the scientific enterprise, as well as the importance of continuing our nation's openness to the world's best and brightest. They noted, however, the need for increased inter-agency coordination of grant policies and greater awareness of the security threat by research institutions.

John Brown, Assistant Director, Counterintelligence Division, Federal Bureau of Investigation (FBI)

- The FBI is seeking additional means to identify those targeting U.S. research discoveries.
- Each of the 56 FBI field offices has a taskforce, which works with a centralized counterintelligence national task force. Each field office has unique relationships with local



institutions.

- The FBI is committed to working with the higher education research community to improve guidelines, and the Bureau has noted an improved willingness by institutions to address this issue.
- Engagement with the higher education research community is conducted through the FBI's Office of the Private Sector.
- The FBI was not at liberty to disclose in an open hearing how they are tracking talent programs given the secrecy around these programs now.

Rebecca Keiser, Office Head, Office of International Science and Engineering, National Science Foundation (NSF)

- NSF is committed to confronting the science and security threat, and noted compliance with disclosure requirements is extremely important.
- A joint NSF- JASON advisory report is expected by the end of the year.
- NSF supports efforts to harmonize disclosure forms and is in the process of adopting the NIH Biosketch process in addition to sharing its own resources on conflicts of interest.
- NSF already requires responsible conduct of research training and could add ethical and research integrity training as part of that requirement.
- NSF also recognizes the need to provide modules to help institutions and ensure compliance.
- Increased federal funding in research and development is needed to respond to China's increased investment in science and technology.

Michael Lauer, Deputy Director for Extramural Research, National Institutes of Health (NIH)

- As of October 2019, seventy institutions have been contacted with specific NIH concerns. The current investigations caseload is in the hundreds, and NIH has currently identified 140 individuals of concern.
- NIH has seen significant violations of its Terms and Conditions as it relates to conflicts of interest and is training staff to report suspicious activity as it relates to the peer review process.
- Individuals who are guilty of infractions are a small percentage of those supported with NIH funds.
- NIH is developing resources to help investigators and is working with OSTP to better coordinate federal efforts.
- There is concern over the morale of foreign-born researchers and the need to continue U.S. collaborations with foreign countries.

**2019 White House Summit of the Joint Committee on the Research Environment (JCORE):** In May 2019, The National Science and Technology Council (NSTC) established a Joint Committee of the Committee on Science and the Committee on Science and Technology (S&T) Enterprise to address issues related to research environment safety, integrity, and productivity. Specifically, the Joint Committee will examine:

- Administrative burdens on federally-funded research,
- Rigor and integrity in research,
- Safe, inclusive, and equitable research settings,
- Open research environments balanced with security.

These cross cutting issues align efforts across both NSTC Committees and bring together the leadership of the two Committees in elevating research environment challenges, engaging the scientific community, and convening interagency problem solving.

JCORE has a focus on four key areas. The first one is **research integrity**, which is fundamentally focused on people playing by the rules. It does not matter where you are from. If you sign up to do research, you do not plagiarize, you do not falsify, you do not fabricate, you do not fail to disclose, you do not fail to do what is required of you in the research community. And if you do, then you are fundamentally violating the central values of research. The values we live by are the ones I mentioned. Research integrity is extremely important, robust reproducibility is critical.

The next area of focus is **research security**. We must make sure that we appropriately balance the openness that is so important in making our research enterprise the world leader with the recognition that we face new challenges and threats today to our research enterprise. We have to find ways to maintain the degree of openness that is vital to research success while being vigilant and putting in place appropriate mechanisms to guard our intellectual property, our ideas, and proposals.

The third area of focus is **safe and inclusive research environments**. I mentioned this before. Safety includes laboratory safety, physical safety. It also includes diversity in the broadest sense and ensuring our research environments are free from harassment of any kind. Such harassment is inconsistent with the research values we hold dear. Again, values and integrity are fundamental to the entire research enterprise.

Lastly, **administrative workload** is the fourth area of focus that also crosscuts all the areas we already discussed. Research workload is a critical area. The Federal Demonstration Partnership has done surveys for the last twenty some years that show faculty at our universities spend about 42-44% of their time, on average, on administrative activities when they are funded by federal research grants and contracts. The EarthCube portfolio will consist of interconnected projects and activities that engage the geosciences, cyberinfrastructure, computer science, and associated communities. The portfolio of activities and funding opportunities will evolve over time depending on the status of the EarthCube effort and the scientific and cultural needs of the geosciences community.

### **Grant Program: Next Generation Software for Data-driven Models of Space Weather with Quantified Uncertainties (SWQU)**

**Brief Description:** This solicitation addresses the overlapping objectives of the [National Space Weather Strategy and Action Plan](#) (NSW-SAP) and the [National Strategic Computing Initiative \(NSCI\) Update](#) through a pilot program. The goal of this pilot program is to transform development of predictive modeling of the coupled evolution of the magnetized solar atmosphere and the solar wind, and their interaction with the Earth's magnetosphere and upper atmosphere. This requires advancing our understanding of the necessary and sufficient requirements of model complexity, computational performance, and observational inputs. The pilot program is also expected to directly contribute to the long-term goal of creating space weather models with quantifiable predictive capability.

Subject to availability of funds and receipt of sufficient quality proposals; the anticipated total funding amount includes joint funding from NSF and NASA. The awards are expected to be at the level of \$500K-\$1M per year; a total award for three years is expected to be in the range of \$1,500,000 – \$3,000,000.

Future ultra-low energy storage-based computing systems can be built on principles derived from organic systems that are at the intersection of physics, chemistry, biology, computer science and engineering. Next-generation information storage technologies can be envisioned that are driven by biological principles and use biomaterials in the fabrication of devices and systems that can store data for more than 100 years with storage capacity 1,000 times more than current storage technologies. Such a research effort can have a significant impact on the future of information storage and retrieval technologies. This focused solicitation seeks high-risk/high-return interdisciplinary research on novel concepts and enabling technologies that will address the fundamental scientific issues and technological challenges associated with the underpinnings of synthetic biology integrated with semiconductor technology. This research will foster interactions among various disciplines including biology, physics, chemistry, materials science, computer science and engineering that will enable in heretofore unanticipated breakthroughs.

## **Grant Program: Environmental Convergence Opportunities in Chemical, Bioengineering, Environmental, and Transport Systems (ECO-CBET)**

**Brief Description:** Creating solutions to pressing environmental and sustainability challenges will require input and imaginative approaches from various fields, perspectives, and disciplines. The National Academies of Sciences, Engineering and Medicine (NASEM), in their report "[Environmental Engineering for the 21<sup>st</sup> Century: Addressing Grand Challenges](#)," identified five critical challenges we must address as a society:

- Sustainably supply food, water, and energy
- Curb climate change and adapt to its impacts
- Design a future without pollution and waste
- Create efficient, healthy, and resilient cities
- Foster informed decisions and actions

The report further states, "The challenges provide focal points for evolving environmental engineering education, research, and practice toward increased contributions and a greater impact. Implementing this new model will require modifications in educational curriculum and creative approaches to foster interdisciplinary research on complex social and environmental problems." This solicitation aims to address these grand challenges by supporting a collaborative research model that seamlessly integrates sustainability, environmental engineering, and process science and engineering.

Accordingly, the Environmental Convergence Opportunities in Chemical, Bioengineering, Environmental, and Transport Systems (ECO-CBET) solicitation will support activities that confront vexing environmental engineering and sustainability problems by uncovering and incorporating

fundamental knowledge to design new processes, materials, and devices from a systems-level perspective. Projects should be compelling and reflect sustained, coordinated efforts from interdisciplinary research teams. A key objective of the solicitation is to encourage conversations and robust collaborations amongst the chemical process, transport phenomena, bioengineering, and environmental and sustainability research communities such that unanticipated solutions may arise. Furthermore, training the future workforce to actively engage and be successful in interdisciplinary research will be necessary to continually innovate given the scope of the environmental problems faced by our global community.

**Brief Description:** Through the IUSE framework, NSF coordinates its investments in undergraduate programs and undergraduate STEM education to maximize impact, and to use shared metrics and appropriate program evaluation approaches. These investments are made across all directorates and address both STEM education in general and specific disciplinary needs. IUSE investments support a variety of activities including the inclusion of inquiry-based and active learning approaches in undergraduate STEM instruction, efforts to increase undergraduate STEM research experiences and courses, and research on the persistence and graduation of students in STEM programs. In addition, specific emerging cross-disciplinary needs include data science preparation for students in all majors, recruitment and retention of women and of students from underrepresented groups in STEM degree programs, incorporation of undergraduate research in STEM fields for STEM majors and non-majors, and re-envisioning of introductory courses in light of new research findings and theories. IUSE also seeks to broaden participation in STEM fields from all sectors and groups in society and proposers are encouraged to establish linkages, as appropriate, with components of the national network of NSF INCLUDES projects [Reference [2](#) in the Program Description section].

The Directorate for Geosciences (GEO) contributes to the *IUSE* initiative through the *Improving Undergraduate STEM Education: Pathways into the Geosciences - Earth, Ocean, Polar and Atmospheric Sciences (IUSE:GEOPATHs)* funding opportunity. IUSE:GEOPATHs invites proposals that specifically address the current needs and opportunities related to education within the geosciences community through the formation of STEM Learning Ecosystems that engage students in the study of the Earth, its oceans, polar regions and atmosphere. The primary goal of the IUSE:GEOPATHs funding opportunity is to increase the number of students pursuing undergraduate and/or postgraduate degrees through the design and testing of novel approaches that engage students in authentic, career-relevant experiences in geoscience. In order to broaden participation in the geosciences, engaging students from historically excluded groups or from non-geoscience degree programs is a priority. While maintaining elements from the legacy tracks of GEOPATHS, this solicitation features three new funding tracks that focus on Geoscience Learning Ecosystems (GLEs):



1. GEOPaths: *Informal Networks (IN)*. Collaborative projects in this track will support geoscience learning and experiences in informal settings for teachers, pre-college (e.g., upper level high school) students, and early undergraduates in the geosciences.
2. GEOPaths: *Undergraduate Preparation (UP)*. Projects in this track will engage pre-college and undergraduate students in extra-curricular experiences and training in the geosciences with a focus on service learning [Reference 3 in the Program Description section] and workplace skill building.
3. GEOPaths: *Graduate Opportunities (GO)*. Projects in this track will improve research and career-related pathways into the geosciences for undergraduate and graduate students through institutional collaborations with a focus on service learning and workplace skill building.

**Grant Program: Future of Work at the Human-Technology Frontier: Core Research (FW-HTF)**

**Brief Description:** The Future of Work at the Human-Technology Frontier (FW-HTF), one of the Big Ideas, is one mechanism by which NSF is responding to the challenges and opportunities for the future of jobs and work. The overarching vision is to support convergent research to understand and develop the human-technology partnership, design new technologies to augment human performance, illuminate the emerging socio-technological landscape, understand the risks and benefits of new technologies, understand and influence the impact of artificial intelligence on workers and work, and foster lifelong and pervasive learning.

The landscape of jobs and work is changing at unprecedented speed, enabled by advances in computer science and engineering, deeper understanding of societal and environmental change, advances in the learning sciences, and new conceptions of work and workplaces. This technological and scientific revolution presents a historical opportunity to the Nation and its people, in the creation of new industries and occupations, enhanced productivity and quality of work life, and the potential for more people to participate in the workforce, ultimately yielding sustained innovation and global leadership. But, as history teaches, such changes also come with risks. Some risks are immediate, such as jobs lost to automation or demand for skills not met by current educational pathways. Other equally important risks include new security threats, algorithmic biases, unanticipated legal consequences including privacy implications, dependence on technology and erosion of human knowledge and skills, inadequate workplace policies and practices, or undesirable impact on the built environment.

The specific objectives of the Future of Work at the Human-Technology Frontier program are to (1) facilitate convergent research that employs the joint perspectives, methods, and knowledge of computer science, design, engineering, learning sciences, research on education and workforce training, and social,



behavioral, and economic sciences; (2) encourage the development of a research community dedicated to designing intelligent technologies and work organization and modes inspired by their positive impact on individual workers, the work at hand, the way people learn and adapt to technological change, creative and supportive workplaces (including remote locations, homes, classrooms, or virtual spaces), and benefits for social, economic, educational, and environmental systems at different scales; (3) promote deeper basic understanding of the interdependent human-technology partnership to advance societal needs by advancing design of intelligent work technologies that operate in harmony with human workers, including consideration of how adults learn the new skills needed to interact with these technologies in the workplace, and by enabling broad workforce participation, including improving accessibility for those challenged by physical or cognitive impairment; and (4) understand, anticipate, and explore ways of mitigating potential risks arising from future work at the human-technology frontier. Ultimately, this research will advance understanding of how technology and people interact, distribute tasks, cooperate, and complement each other in different specific work contexts of significant societal importance. It will advance the knowledge base related to worker education and training and formal and informal learning to enable all potential workers to adapt to changing work environments. It will advance our understanding of the links between the future of work at the human-technology frontier and the surrounding society, including the intended potential of new technologies and the unintended consequences for workers and the well-being of society.

For the purposes of this solicitation, work is defined as mental or physical activity to achieve tangible benefit such as income, profit, or community welfare. The Future of Work at the Human-Technology Frontier is, in turn, a conceptualization of work in the future that will be enabled or improved by advances in intelligent technology and their synergistic integration with human skill to achieve broad participation in the workforce and improve the social, economic, and environmental well-being of society. To reach this goal, research is sought that is anchored in work. Proposals must clearly define the work and work context addressed by the research. Technological innovations should be integrated with advances in the learning sciences, research on education and workforce training, and social, behavioral, and economic science perspectives. Potential results should contribute to fundamental advances in optimizing the human-technology team, the science and technology of future workforce development and education, work environments, and positive work outcomes for workers and society at large. Proposals are encouraged that are oriented toward the future of work at the human-technology frontier and that are not overly couched in current technology or work practices.

A proposal for a research grant in this program must focus on advancing fundamental understanding of future work, and potential improvements to work, workplaces, workforce preparation, or work outcomes for workers and society. It must be convergent research that addresses the human and societal dimensions as well as the technological innovation and their potential impact on future work. In doing so, the research should make significant contributions to both intellectual merit and broader impact. Achieving this goal requires integration and convergence of disciplines across behavioral science, computer science, economic science, engineering, learning sciences, research on education and workforce training, and the social sciences. A convergent perspective is essential to understand and shape long-term social and economic drivers, so that advanced intelligent technology will strengthen the social fabric. A convergent perspective also provides insights into education and re-skilling, so that the benefits of emerging technology can be conferred upon both current and future workers.

**Awards:** Standard grants. Anticipated Funding Amount: \$30,000,000. Up to 15 Planning Grant Awards and up to 15 Research Grant Awards.

Two classes of proposals will be considered through this solicitation:

1. FW-HTF Planning Grants (FW-HTF-P) may be requested for a total budget not to exceed \$150,000 for a period of 1 year.
2. FW-HTF Research Grants (FW-HTF-R) may be requested at two levels:

- a. Medium FW-HTF-R proposals may request support for a period of up to 3 years, with a total budget not to exceed \$1,500,000.
- b. Large FW-HTF-R proposals may request support for a period of up to 4 years, with a total budget between \$1,500,001 and \$3,000,000.

**Brief Description:** The Nation's advanced research cyberinfrastructure (CI) ecosystem catalyzes discovery and innovation across all areas of science and engineering (S&E) research and education. The increasingly complex and rapidly evolving S&E landscape requires *an agile, integrated, robust, trustworthy, and sustainable CI ecosystem* that will drive new thinking and transformative discoveries in all areas of research and education.

The success of this vision depends on the ability of the research community to be able to easily and effectively access and use state-of-the-art research CI resources and services in a timely way. This, in turn, drives a set of requirements on the development, operation, and evolution of the CI ecosystem. The NSF Cyberinfrastructure Centers of Excellence (CI CoE) Program aims to realize the above vision by supporting hubs of expertise and innovation targeting specific areas, aspects, or stakeholder communities of the research CI ecosystem. Supported CI CoEs provide expertise and services related to CI technologies and solutions; gather, develop, and communicate community best practices; and serve as readily-available resources for both the research community and the CI community. A key objective of this program is to support CI CoEs that drive advancements in and positively impact the CI ecosystem through structured but strongly community-engaging and community-serving approaches. Overall, CI CoEs are a means of concentrating resources on a specific area of identified need in support of the broader goal of advancing capabilities and performance of the national CI ecosystem [<https://trustedci.org/>].

**Brief Description:** In 2016, the National Science Foundation (NSF) unveiled a set of "[Big Ideas](#)," 10 bold, long-term research and process ideas that identify areas for future investment at the frontiers of science and engineering. The Big Ideas represent unique opportunities to position our Nation at the cutting edge of global science and engineering leadership by bringing together diverse disciplinary perspectives to support convergence research. As such, when responding to this solicitation, even though proposals must be submitted to the Directorate for Geosciences, once received, the proposals will be managed by a cross-Directorate team of NSF Program Directors.

Major goals of NSF's NNA Big Idea include:

The Understanding the Rules of Life: Microbiome Theory and Mechanisms (URoL:MTM) program is an integrative collaboration across Directorates and Offices within the National Science Foundation. The objective of URoL:MTM is to understand and establish the theory and mechanisms that govern the structure and function of microbiomes, a collection of microbes in a specific habitat/environment. This may include but is not limited to host-associated microbiomes, such as those

with humans and other organisms, where i) the microbiome impacts host physiology, behavior, development, and fitness; ii) the host influences the metabolic activity, dynamics and evolution of the microbiome, and iii) the environment (biological, chemical, physical, and social) influences and is influenced by both the host and the microbiome.

The URoL:MTM program invites integrated, interdisciplinary proposals that develop theoretical predictive frameworks with well-designed experimental and/or computational approaches to generate and test hypotheses about the causal relationships within the microbiome, and among the microbiome, host, and environment. How these relationships affect robustness, resilience, and adaptability of individual organisms, populations, and communities are also of interest. Projects may apply existing ecological and evolutionary theory or develop new experimental, computational, or mathematical tools, models, and theory to: i) explain function and interactions in natural, experimental, and model microbiomes; ii) elucidate the molecular mechanisms that underlie communication between the host and the microbiome and among the members of the microbiome; and/or iii) comparatively analyze microbiomes to discover emergent properties that provide insight into the behavior of living systems.

Successful projects will contribute to a portfolio of research that identifies general principles ("rules") that underlie a wide spectrum of biological phenomena across spatial, temporal (from sub-second to geologic), and/or complexity (molecular, cellular, organismal, population) scales. This includes retrofits to existing power generators as well as greenfield systems with a carbon-containing fuel input and electricity as an output (i.e., a "black box" in which the nature of the fuel-to-electricity conversion process is not prescribed).

The value of such CCS technologies will be evaluated by their impact on the system LCOE of a net-zero carbon electricity grid, as determined by capacity expansion modeling. ARPA-E does not expect every CCS technology itself to be a net-zero carbon process; instead the cost and performance of each project selected under this FOA will be evaluated in the context of a net-zero carbon system which may include negative emission assets. Recent work suggests that a system LCOE of \$75/MWh for a net-zero carbon electricity system is aggressive yet possible.

FLECCS is a 2-phase program. Phase 1 focuses on designing and optimizing innovative CCS processes that enable flexibility on a high-VRE grid. Phase 1 will last for approximately 15 months and include approximately \$7 million in Federal funding. Based on the output of the individual projects, engineering design review, and capacity expansion analysis, ARPA-E will select projects to continue to the next phase. Phase 2 will focus on building components, unit operations, and small prototype systems to reduce the technical risk and cost associated with these CCS systems. This phase will last for approximately 3 years and have a total budget of approximately \$36 million in Federal funding.

## **Proposal Submission and Streamlyne Information**

### **Internal Timeline for Successful and Timely Proposal Submission**

Recently federal agencies including NSF, NIH and DoE/DoD have emphasized and requested Principal Investigators and institutions to submit their proposals well before the posted deadline to avoid unexpected problems in online submissions with respect to system error checks and additional needs of subsequent revisions.

For example, NSF clearly stated during the CAREER program webinar held on May 9, 2019 posted on <https://www.nsf.gov/career> that any response from help desk within the last four days of the deadline may not be provided on the same day. NSF warned that the **questions related to errors and other proposal submission issues in the last 72 hours before the deadline may not be answered on time for submission.**

The NJIT Proposal Submission Guidelines and Policy posted on the website <https://research.njit.edu/research-policies> provides the institutional timeline in order to help faculty and staff Principal Investigators for successful proposal submission. We are requesting all Principal Investigators, faculty, staff and administration to follow the proposal submission to help everyone to submit a successful proposal on time, preferably before the deadline as requested by federal funding agencies. The following are the NJIT Proposal Submission Guidelines modified for Streamlyne proposal submission system:

- **1 month (or earlier) before the due date:** initiate the proposal submission process in Streamlyne with a notice of intent to apply to college POC and SRA including the request for proposal identification number (NSF, NIH) and/or the RFP document. This is an important step that will help the College POC and SRA to manage your proposals. It will allow:
  - preliminary review of needs and sponsor requirements (meeting recommended)
  - set up the timeline in motion and internal checklist/deadlines
  - collaborator outreach and intake requirements (where applicable)
  - set up the budget and Streamlyne document development process including any cost-sharing for consideration of department, college and office of research administration.
- **1 month - 2 weeks before due date:** the budget should be finalized and the approval process should be initiated. This includes the department and college approvals, conflict of interest forms, the detailed budget and justification, proposal title, and preliminary specific aims (NIH), proposal summary (NSF), or contract scope of work (SOW). The following checklist should be followed:
  - Proposal budget
    - Internal budget commitments such as cost-sharing should be fully calculated/loaded at this time. Any college specific internal process for index source and approvals should be followed within this timeline.
  - Complete initial proposal details and internal Streamlyne information
  - Complete Streamlyne questionnaires
    - Proposal specific
    - Sponsor specific (as applicable for grants.gov for S2S submission)
  - Complete special review disclosures (as applicable)
    - IRB/human subjects
    - Biosafety

- Animals
- Export Controls
- Conflict of Interest
- **2 weeks - 1 week before the due date:** submit all required internal attachments including:
  - Project Summary/Statement of Work
  - Final Budget
  - Budget Justification
  - For S2S Proposals – Complete additional input of placeholder attachments.
  - Submit in Streamlyne and monitor routing/review by key personnel and department/college administration.
- **72 hours – 24 hours before the submission deadline:** Prepare the final version for submission. The following actions will be managed during this period.
  - All final technical documents/attachments are completed and validated in internal and/or sponsor system(s).
  - Central Office completes final review and coordination with PI and College POC on final proposal review, validation of system requirements and engages in sponsor actions and submission.
  - Central office completes internal data and archiving procedures and coordinates follow-up
- **At least 24 hours before the submission deadline:** The PI should release the final version of the proposal to the SRA office at least 24 hours prior to the deadline for on-time submission.

For a successful submission, it is expected that faculty/PIs will follow up with the designated point-of-contact (ambassadors) for their college in a timely manner so that appropriate planning steps can be managed with respect to the proposal complexity, scope of support, any special needs such as cost-sharing, and multiple submission volume with the same due date.
